

Supporting Documents for Individuals / Juristic Persons

A copy of identification documents in the case of general undertakings submitted to Thailand Securities Depository Co., Ltd. ("TSD") may contain sensitive personal data whereby such information is not necessary for the provision of service by TSD and TSD has no intention of storing such sensitive personal data. As a result, the document owners may proceed to cross out any part in order to cover up any sensitive personal data before submitting the identification documents containing such sensitive personal data to TSD. In an event no action is taken to cover up such sensitive personal data, TSD shall deem that you have consented to the storage of such sensitive personal data.

Furthermore, in case special action is required (such as where fingerprint is used instead of signature) such that additional information must be submitted which may include sensitive personal data and such additional information may be necessary for the provision of service by TSD, not providing such additional information may prevent TSD from providing the service to you. Also, in submitting such additional information, you agree and consent to TSD processing such sensitive personal data for the purpose of service provision.
