Submission Guidelines:

A professional licence holder who wishes to ask for approval for the collection of Continuing Professional Education (CPE) hours for Investment Consultant (IC) or Investment Analyst (IA) or Investment Planner (IP) should initially submit the following information to the Stock Exchange of Thailand (SET) in order to be able to access to TSI Courses Accreditation System (TSI CAS). Please submit the form with relevant attachments to email: "ExaminationandTrainingStandardUnit@set.or.th"

Qualifications:

A professional licence holder should be one or more of the following persons:

- (1) A professional practitioner, university lecturer, visiting lecturer giving lecture to any approved professional refresher courses that have not ever approved before.
- (2) A professional licence holder who has passed one or more of the following refresher courses of autoaccredited institutions:
 - a. CFA Institute
 - b. Global Association of Risk Professional
 - c. Certified Financial Planner Board of Standards, Inc., or Financial Planning Standards Board
 - d. Chartered Institute for Investment & Securities (CISI)

Terms and Condition:

- (1) I, a professional licence holder, who submit and sign on this request form certify that the information and attached documents are complete and correct.
- (2) I understand and obey the procedure of submitting my professional refresher courses to TSI CAS system for the collection of CPE hours for IC or IA or IP.
- (3) I am committed to carefully keep my user name and password for the access to TSI CAS system to be confidential.
- (4) I am committed to be responsible for the submission for the approval of my CPE hours via TSI CAS as the same as the submission via signed paper form.
- (5) I am committed to allow the Stock Exchange of Thailand collect and use my personal information on identification card or passport or other official issued cards and/or any information in TSI CAS system in order to verify my identity.
