Checklist: Making/ Filing Tender offer

<u>1st Case:</u> A listed company making a tender offer is required to disclose the information according to Item 1-3 and complete the checklist to disclose transactions deemed as acquisition and disposition of assets.
<u>2nd Case:</u> A listed company which is offered a tender offer is required to disclose the information according to Item 1-4.


While a major shareholder is negotiating with prospective buyer, the listed company must ensure that parties involved in the negotiation shall keep details about the negotiation confidential and ensure that persons acting as the agent, proxy or financial advisor perform their duty with responsibility and protect the confidential information.

If the offeror or offeree is a listed company, the company will ensure that such listed company will disclose the information through the SET at the same time.

*** If the offeror agrees to cancel the tender offer intention during the purchase acceptance period, submission can be made within 3 business days before the end of the purchase acceptance period.
