






SETSMART Extranet

SETSMART Extranet is an information database system developed by the Stock Exchange of Thailand. The service is a comprehensive source of information which seamlessly integrates real-time information, historical trading prices and indices, listed companies information and news, and key statistics information all in one service. Users will be able to learn and use the system easily through the user friendly interface. Moreover, the system is designed to be a web-based application to reduce software installation complications. Just open a web browser and you are ready to go.

The service is presently available through the internal network of the Stock Exchange of Thailand (www.setsmart.set). There are 3 versions of SETSMART Extranet, categorized by the contents and functions.
