The qualifications of stocks listed on foreign exchanges that may be the eligible for derivatives warrants

The Stock Exchange of Thailand ("SET") specifies the qualifications of stocks listed on foreign exchanges that may be underlying assets of derivative warrants as follows;

- 1. possess all the qualifications stipulated by the SEC notifications;
 - Have quarterly average market capitalizations of not less than THB 10,000 million for 4 consecutive quarters, and
 - Trading in a foreign exchange that have any of the following characteristics;
 - Regulated by an entity that is an ordinary member of IOSCO (International Organization of Securities Commissions)
 - O A member of WFE (World Federation of Exchanges)
 - O Located in GMS (Greater Mekong Subregion) countries
- 2. possess qualified in terms of market capitalization as prescribed by SET with the quarterly average market capitalization of not less than THB 200,000 million for the latest quarter.
