1. Introduction

1.1 Overview

The financial statement service will provide financial data for listed companies based on member subscriptions. Members can call APIs to retrieve the latest financial data at 4AM BKK time each day.

For all companies subscription:

<u>The first use</u>: Members are required to retrieve complete data from the Financial Statement API according to subscriptions. This ensures they have a full baseline of information. It is recommended that members also retrieve data from the Last Update Date API to record the last update date for each quarter.

<u>Daily updates</u>: SET recommends that members retrieve data from the Last Update Date API first and compare the last update date to check which quarter data has been updated and then retrieve data from the Financial Statement API only for the updated quarter to replace your database with the latest financial data. For example:

- Compare the last update date and discover that Q4/2024 data has been updated.
- Retrieve data from the Financial Statement API and replace all current data where the 'asOfDate' is in Q4/2024 (between 2024-10-01 to 2024-12-31).

1.2 Authentication

- 1. Go to www.set.or.th/smartmarketplace.
- 2. Go to "API Key" in the left menu panel and login with your registered username/password.
- 3. Create your API key.
- 4. Use the created API key as a parameter to retrieve data via API.

Note: SET recommends that members renew API key every 6 months to 1 year in accordance with company's security policy
