Part 1: Introduction

The Stock Exchange of Thailand ("SET") has reviewed the rules related to securities trading on both SET and mai across various aspects to ensure that they remain appropriate for the current market environment and trading conditions, without imposing unnecessary obstacles for investors, and in line with international stock exchange practices. Therefore, SET deems it appropriate to further amend these rules as follows:

- Board Lot Adjustment: The board lot size will be reduced to 10 shares per Board Lot specifically for securities with a closing price of 50 baht or higher continuously for a period of 6 months, in order to align with the ticket size of retail investors (The Board Lot size for general securities will remain unchanged at 100 shares).
- Ceiling & Floor Adjustment for New Listings: The floor level for newly listed securities will be reduce to 0.5 times the IPO price, while the Ceiling will remain unchanged at no more than 3 times the IPO price).

In this regard, SET is seeking input from the stakeholders to gather information that will be beneficial in considering further revisions to related regulations. Part 2: Proposed Amendments

2.1) Board Lot Adjustment

SET has established trading rules requiring investors to specify the number of securities based on a trading unit (Board Lot) to ensure appropriate transaction sizes. Currently, 1 Board Lot equals 100 shares¹, except for securities with a closing price of 500 baht or higher continuously for a period of 6 months, where 1 Board Lot equals 50 shares, or calculated as a minimum ticket size of 25,000 baht.

Most international stock exchanges in the region, such as BURSA, SGX, and IDX, set the Board Lot size for common stocks at 100 shares, similar to SET, except for HKEX, which sets different Board Lot sizes depending on the issuer's policy.

SET has studied data regarding the trading behavior and trends of retail investors and stock prices. The conclusions are as follows:

• Retail Investor Trading Behavior

- The ticket size of retail investors has been trending downward, with most having a ticket size of no more than 5,000 baht.
- The proportion of retail investors with a ticket size not exceeding 500 baht has been continuously increasing, with 16% in 2024 (up from just 9% in 2019).

• Majority of Stock Prices

- Approximately 95% of securities priced below 50 baht, as well as SET100 stocks, are priced between 5 and 50 baht

Proposal:

To align the Board Lot size with the trading behavior of retail investors, particularly the new generation of investors, most of whom have an average ticket size of no more than 5,000 baht, and to enhance investment opportunities across a wider range of price levels, SET proposes the following adjustments to the Board Lot requirements:

2.2) Ceiling & Floor Adjustment for New Listings

Currently, SET applies wider price limits (Ceiling & Floor) for the first trading day of common stocks compared to those applied during regular trading days. The Ceiling for the first trading day is set at no more than 3 times the initial public offering price (IPO) and the floor is set at no lower than 0.01 baht (equivalent to 1 time the IPO price). This price limit structure aims to provide a sufficiently wide price range to facilitate appropriate price discovery by investors, while still maintaining market stability and preventing excessive price volatility.

International stock exchanges, such as BURSA and KRX, apply different Ceiling & Floor limits for newly listed common stocks compared to SET. Specifically, these exchanges allow for a wider Ceiling range while imposing narrow Floor limits. BURSA and KRX set the Floor at 30% and 60% of the IPO price, respectively.

The price movements of newly listed common stocks (New Listings) on SET over the past five years reveal that, among 175 New Listings, only 4% reached prices close to the Ceiling level. In contrast, some stocks recorded trading prices declined by as much as 45% below their IPO price.

Proposal:

To reduce the impact of price declines in New Listings on the first trading day, thereby helping to limit investment risks for investors and aligning with practices of international stock exchanges, which generally apply narrower Floor limits for first-day trading, SET proposes the following amendments to the trading price limits for New Listings as outlined below:
